

Southern Marine Planning Conference 2010

30 September 2010, City Cruise Terminal, Southampton

Introduction

This one day conference will provide planners and users of the coastal and marine environment with the tools to help them prepare for a local marine planning system. It will provide an update on marine planning, will explore how Solent Stakeholders can be involved in the system and will present a database of marine planning policies for the Solent. It will also deliver the results of Solent Forum's SoMaP Project (Towards Solent Marine Planning).
