Projects and Events 1

Solent Seascapes Project and the Solent Recovery Plan (2022-2027)

The Solent Forum is on the advisory group for the SSP and chairs the Solent Recovery Plan Working Group. The Solent Recovery Plan Strategy includes a data portal and State of Nature report which will inform the voluntary management plan. The plan will focus on how to remove pressures (particularly from non-licensable activities) that are damaging the habitats and species. This work will also deliver the NEG Bird Sensitivity and Activity Mapping Project.

○ Solent Marine Nature Recovery (2024 – 2025)

Solent Forum liaising with key stakeholders to assist with the joining up of the marine space with the forthcoming Local Nature Recovery Strategies being produced by Hampshire County Council, West Sussex and Isle of Wight and in partnership with Solent Seascapes Project. A webpage has been produced and a scoping document drafted to assist. Solent Forum - Solent Nature Recovery Scoping. A joint workshop is being discussed to be held February/March 2024. SF recently responded to a NE survey on how marine can be incorporated into LNRS.



Projects and Events 2

Beneficial use of Dredgings in Solent (BUDS) Closing

Phase 2 complete. Phase 3 – Bottom Placement of dredgings project commenced April/May 2021. Final project report due. Phase 4 – Saltmarsh Restoration requires funding.

Sea the Value (2022 – 2025)

Working with PML and University of Portsmouth. Understanding of the role marine biodiversity plays in providing regulating services, and in particular carbon sequestration and bioremediation of waste, valuing these services and applying these values in a policy context. Approaches will be applied and developed at a both local/regional and national scale, including the two case study sites of the Solent and the Moray Firth. Three workshops in the Solent (one already held and other planned for October).

Solent Forum Business Plan (2025 – 2030)

Business planning will commence at the February Steering Group meeting when we will present the proposed methodology to you.
