### **Introduction**

The day's programme consists of:

- Viewpoints by different organisations including the Marine Conservation Society and Surfers Against Sewage.
- Presentation on the need for Combined Sewer Overflows and their function.
- Implications of climate change for water quality.
- Introduction of the new Solent Water Quality Awards.

The conference will be held at Explosion, The Museum of Naval Firepower, in Gosport. This is an award winning, hands on, interactive museum telling the story of naval warfare from the days of gunpowder to modern missiles.
